Composition (INCI): AQUA (WATER), SORBITOL, SODIUM LAURETH SULFATE, SODIUM CHLORIDE, PROPYLENE

GLYCOL, DISODIUM LAURETH SULFOSUCCINATE, PEG-18 GLYCERYL OLEATE / COCOATE, COCO-GLUCOSIDE, DECYLENE GLYCOL, C12-15 ALKYL BENZOATE, LAURETH-6, CITRIC

ACID

Properties: HERWEDERM CLEAN SENSITIVE is an extremely mild washing liquid for hand and whole

body cleansing. HERWEDERM CLEAN SENSITIVE contains specially selected washing raw materials and, thanks to the absence of fragrances, preservatives\* and dyes, is ideally suited for cleansing extremely stressed and very sensitive skin. The pH value is slightly acidic. HERWEDERM CLEAN SENSITIVE has been dermatologically tested on atopic patients with very good results. The results were confirmed by measurements on the BUS

model.

Fields of application: HERWEDERM CLEAN SENSITIVE is suitable for the gentle cleaning of sensitive and pre-

damaged skin in all work areas such as administration, trade and industry. HERWEDERM CLEAN SENSITIVE is particularly suitable for use in hospitals, care wards and old people's homes as well as in food processing companies. The requirements placed on skin prod-

ucts within the framework of a HACCP concept are fulfilled.

Use: Apply a small amount of HERWEDERM CLEAN SENSITIVE to slightly moistened skin and

spread well. The fine-pored and creamy foam can be rinsed off effortlessly and quickly

with sufficient water.

Regulatory framework: HERWEDERM CLEAN SENSITIVE is subject to the EU Cosmetics Regulations and corre-

sponds to it in its current version. It does not have to be labelled according to the regula-

tions on hazardous substances.

Storage and shelf life: HERWEDERM CLEAN SENSITIVE can be kept for 30 months at room temperature (from

date of manufacture). The date of expiry is denoted on the packaging.

Packaging size: 250 ml bottle, 2000 ml pouch bottle

Dispensing-system: HERWEMAT HERO and HERWEMAT UNI

**Disposal:** The cardboard boxes, tubes and plastic packaging are recyclable.
