It is breathable and highly effective due to the addition of special film-forming agents. HERWEDERM PROTECT SENSITIVE is free of silicones, preservatives*, perfumes and colorants and dermatologically tested on atopic skin. Suitable also for sensitive skin types.
Composition (INCI):	AQUA (WATER), SODIUM ACRYLATE / SODIUM ACRYLOYL DIMETHYL TAURATE COPOLYMER, GLYCERIN, POLYPERFLUOROETHOXYMETHOXY DIFLUOROETHYL PEG PHOSPHATE, POLYVINYL ALCOHOL, CAPRYLIC/CAPRIC TRIGLYCERIDE, DECYLENE GLYCOL, ACRYLATES COPOLYMER, ALLANTOIN, SODIUM HYDROXIDE, CITRIC ACID
Properties:	HERWEDERM PROTECT SENSITIVE provides an effective protection against direct skin contact with various substances. It soaks in rapidly and forms an elastic, non-slip, breathable and invisible protective layer. HERWEDERM PROTECT SENSITIVE is free of silicones, perfume and causes no fingerprints. It contains no colourants and preservatives*. The skin compatibility has been tested by skin-healthy persons and atopic patients with very good results.
Fields of application:	HERWEDERM PROTECT SENSITIVE is a special protective preparation against water and non-water based substances and furthermore against not clearly defined skin hazards. It is universally usable. HERWEDERM PROTECT SENSITIVE is recommended especially for extremely sensitive skin types, e.g. in the food industry, in hospitals or nursery homes and in electrical engineering as well as for metal industry and other branches of industry. Has proven itself in the food processing industry and fulfils the requirements placed on skin products within the framework of a HACCP concept.
Use:	Always wash and dry the skin thoroughly before applying the cream. Be sure to apply the cream carefully between the fingers and around the nails. HERWEDERM PROTECT SENSITIVE is suitable for faces as well.
Regulatory framework:	HERWEDERM PROTECT SENSITIVE is subject to the EU Cosmetics Regulations and corresponds to it in its current version. It does not have to be labelled according to the regulations on hazardous substances.
Storage and shelf life:	HERWEDERM PROTECT SENSITIVE can be kept for 30 months at room temperature (from date of manufacture). The expiry date is denoted on the packaging.
Packaging size:	100 ml tube, 1000 ml pouch bottle Dispensing-system: HERWEMAT HERO and HERWEMAT UNI dispenser
Disposal:	The cardboard boxes, tubes and plastic packaging are recyclable.
