SECTION 4: First aid measures

4.1 Description of first aid measures

General information

Remove contaminated soaked clothing immediately. If you feel unwell, seek medical advice.

After inhalation

Move to fresh air in case of accidental inhalation of vapours. In the event of symptoms refer for medical treatment.

After contact with skin

Consult a doctor if skin irritation persists.

After contact with eyes

SECTION 5: Firefighting measures

5.1 Extinguishing media
