

HERWE DERMASEPT N GEL

Hand disinfectant gel against bacteria and viruses

Description: HERWE DERMASPT N GEL is an unscented, dye-free, alcohol-containing and slightly vis-

cous preparation for hygienic hand disinfection, effective against bacteria, yeast and vi-

ruses (limited virucidal).

Composition: HERWE DERMASEPT N GEL is an aqueous-alcoholic solution with thickeners and skin-

caring additives. Active ingredient: 63.0 g / 100 g ethanol.

Properties: HERWE DERMASEPT N GEL was developed for hygienic hand disinfection without use of

water .HERWE DERMASEPT N GEL has been tested in accordance with EN 1500 (hygienic hand disinfection) and DVV / RKI guidelines (test for limited virucidal properties) and shows broad efficacy spectrum against bacteria, yeasts, enveloped viruses (e.g. H1N1 (swine flu virus), H5N1 (bird flu virus), HBV, HCV and HIV) as well as against noro- and adenoviruses. HERWE DERMASEPT N GEL is quickly absorbed and, thanks to the addition of

nourishing allantoin, glycerine and a fatty alcohol, is well tolerated by the skin. Listed according to VAH (DGHM) and IHO (virucidal list). Dermatologically tested.

Area of use: HERWE DERMASEPT N GEL is used wherever there is an increased risk of the transmission

of bacteria and viruses, e.g. in industry (food processing, medical device manufacture), in

health care and in care facilities.

Application: Take a sufficient amount of HERWE DERMASEPT N GEL into dry hands. Keep hands moist

with the undiluted product during the entire contact time and if necessary apply hand

disinfectant in portions again.

Contact times:

Hygienic hand disinfection: (EN 1500): 30 sec.
Limited virucidal according to RKI/DW recommendation: 15 sec.
Noroviruses (MNV according EN 14476): 30 sec.
Rotaviruses (EN 14476): 15 Sek.

Regulatory: HERWE DERMASEPT N GEL is subject to the EU biocide product regulation.

BAUA Reg. no. N-71515. 100 g contain 63.0 g of ethanol.

HERWE DERMASEPT N GEL is classified and labeled in accordance with EU law on haz-

ardous substances. The safety data sheet must be observed.

Use disinfectants safely. Always read labelling before use and read product information.

Storage and shelf life: HERWE DERMASEPT N GEL is stable in closed containers at room temperature for 36

months (from the date of manufacture). The respective expiry date is indicated on the

packaging.

Packaging sizes: 150 ml pocket sized bottle, 500ml EURO dispenser bottle, 1000ml EURO dispenser bottle,

1000 ml pouch bottle, 1000 ml VIVA dispenser cartridge, 5 L canister

Recycling: The cardboard and plastic packaging can be added to the local recycling. Only dispose of

the packaging completely emptied for recycling.
