Ingredients (INCI):	AQUA (WATER), GLYCERIN, POLYVINYL ALCOHOL, POLYPERFLUOROETHOXYMETHOXY DIFLUOROETHYL PEG PHOSPHATE, HAMAMELIS VIRGINIANA (WITCH HAZEL) LEAF WATER, BETAINE, DISODIUM COCOYL GLUTAMATE, PHENOXYETHANOL, ALCOHOL DENAT., CAPRYLYL GLYCOL, CITRIC ACID, SODIUM CHLORIDE, PROPYLENE GLYCOL, SODIUM HYDROXIDE, P-ANISIC ACID
Properties:	HERWEFOAM ALL-IN-ONE is a fingerprint-free skin protection foam, which works with proven film-forming agents against both water-soluble and water-insoluble skin hazards and can also be used when working with a variety of skin hazards. Due to the long-lasting dry and elastic protective film, the adhesion of dirt to the skin is also prevented. HERWEFOAM ALL-IN-ONE contains mild moisture-binding substances and is suitable for all skin types with a pH of approx. 5.5. The skin compatibility has been dermatologically tested on atopic skin. HERWEFOAM ALL-IN-ONE is silicone-free as well as free of PEG and plastic beads. The concentrate is dispensed by a foam pump and is very economical to use and resource friendly. A 1 L bottle will provide about 2500 foam applications.
Area of use:	HERWEFOAM ALL-IN-ONE is a special protection product for water-soluble and water- insoluble substances as well as for varying skin hazards. It is universally applicable and is suitable in all work situations with changing working materials, especially if fingerprints have a disturbing effect. HERWEFOAM ALL-IN-ONE is compatible for use under gloves. Typical areas of use are e.g. metalworking and plastic industry as well as electrical engi- neering.
Application:	Apply an appropriate amount of product to the back of the hands and distribute it care- fully. Also, treat the palms and do not forget the space between the fingers. Important areas to cover are the nail beds, fingernails, fingertips and your wrists. After intensive wa- ter contact, HERWEFOAM ALL-IN-ONE should be reapplied for the full protection.
Regulatory:	HERWEFOAM ALL IN ONE is subject to the FDA and EU Cosmetics Regulation and corre- sponds to it in the currently valid version. Labeling in accordance with the Ordinance on Hazardous Substances is not required.
Storage and shelf life:	HERWEFOAM ALL IN ONE is stable in closed containers at room temperature for 30 months (from the date of manufacture). The respective expiry date is indicated on the packaging.
Packaging sizes:	50 ml spray bottle, 1000 ml VIVA dispenser cartridge
