HERCULAN CHERRY PLUS can be used universally in a wide range of industries: mechanical engineering, garages, metalworking, and mining.
Application:	HERCULAN CHERRY PLUS is designed for use in a dispensing system. Ap-ply one to two pumps to dry hands, rub in, add some water and scrub well. When the dirt has dissolved, rinse well with water until the hand is foam- free. When working with highly adhesive materials, it is advisable to apply HERWESAN PRO as a protective cream before work. These protective creams make subsequent cleaning much easier.
Regulatory:	HERCULAN CHERRY PLUS is subject to the FDA and EU Cosmetics Regula-tion and meets the requirements in the current formulation. Labeling in accordance with legislation on hazardous substances is not required.
Storage and shelf life:	HERCULAN CHERRY PLUS is stable in closed containers at room temperature for 30 months (from the date of manufacture). The expiry date is indicated on the packaging.
